Dr. Dorsey announced that David Daugherty, NCI's Faculty-in-Residence for Radford University's IT Program, has been relocated to the Radford home campus. Radford University made this decision; however, the IT Program will continue to be offered through NCI without a Faculty-in-Residence in Martinsville.

**Review and Discussion of Potential Academic Programs in 2010 – 11**

The Environmental Management Certificate Program offered by Ferrum College will be held Spring Semester 2010. Dr. Leslie Lambert, Provost and Vice President for Academic Affairs of Ferrum College, will formally announce this program at the full Board meeting later in the day. Students may also enroll in the course to receive three credit hours.

NCI is partnering with Virginia Commonwealth University to offer a Bachelor of Science in Accounting Degree. Negotiations for the program have only recently been completed. This program will begin Fall Semester 2010.
